## *"Several lawyers have been asked to sell data comprised in the central register of beneficial ownership"* Chair of the Luxembourg Law Society

The words from the Chair of the Luxembourg law society in an email sent to its members last week confirm the concerns raised in our previous correspondence.

By allowing 'immediate, unfiltered, direct and free access' to beneficial ownership information held in national registers" to unregulated sectors of the population, coupled with (a) a "passporting"-system that allows free roaming throughout the EU<sup>1</sup>; and (b) the inability, for beneficial owners to find out the identity of the requesting parties<sup>2</sup>, the new rules are intrinsically flawed and prone to abuse.



Dear colleagues,

The Luxembourg Law Society has been informed that several members have been approached by an unauthorised entity seeking to retrieve data relating to the beneficial owners of local companies via your access to the Register of Beneficial Owners, in return for payment.

We remind you that such solicitation takes place outside any legal framework and falls under criminal law (in particular articles 509-1 et seq. of the Criminal Code).

We invite you to ignore such proposals and to redouble your vigilance. Thank you for your cooperation.



It is time for the EDPS to invoke Art. 42 of Regulation (EU) 2018/1725 and issue an updated opinion to the new rules which were haphazardly modified by the European Parliament without his previous consultation, as would have been required under EU law.
